Eligibility: Amateur and professional, 18 years and older: **LIMITED TO 20 ENTRANTS/DIVISION**

Divisions: Amateurs Junior Men (18-30), Senior Men (31-45), Men's Masters (46-62), Dugongs (63+), Grand Champion (1st, 2nd place winners of each division)

Open Professional. 18 years and over. **NOTE:** may also compete as amateur in this contest!

Women's Open: no entry fee!

Handboard definition: any wave riding device, made of any materials, worn on the hand(s), is less than **16 inches** (40 cm) long, and is **without skegs or fins**.

Paepo Board definition: any wave riding device with a core of natural materials that is less than 55 inches (140 cm) long and is used without a leash or skegs.

Check in time: 8:30 AM on day of event.

Entry fees: including high quality long sleeved T-shirt

Amateur men, pre-event- \$25, **women free**; beach entry at event-\$35

Professional- \$50 (all professional entry fees will form purse for winners)

Judging by 3 judge panel for 1st through 6th places in each division. Highest scores will be given for the most difficult and inventive controlled maneuvers in the most critical section of the biggest and/or best wave for the longest distance. Sportsmanship and safety will also be considered. Only the first 10 waves on which a contestant establishes control will be judged: after catching 10 waves contestant will be required to leave the contest area or be subject to disqualification. The scores of the 3 waves receiving the highest scores will be totaled to determine placement by each judge; as necessary the scores of the fourth and subsequent waves will be tallied to break any ties. Interference is defined as having adversely affected the ride of another contestant who already had established right of way and control on a given wave: the contestant judged by at least 2 judges, to have interfered will receive a score of zero for that wave and it will be counted as one of his/her 3 tallied scores. Any handboard/gloves meeting definition may be used.

Awards: perpetual trophies previously won by **REDWINGS** for 1st, 2nd, 3rd place in each division
REDWINGS World Champion Handboarder Perpetual Trophy for Grand Champion. Minimum purse of \$350 for **World Professional Handboard Champion** (entry fees will form purse).
